PROFILE

Kepa is founder, partner and CEO of Global Factor since March 2004. The group has become one of the leading firms specialising in climate change, renewable energy, environmental commodities and sustainability, with offices in Spain (Bilbao, Madrid), Italy (Milan), Germany (Berlin), Ecuador (Quito) and Mexico (Mexico City).
